Administrative fee payment instructions

For generating and issuing unique identifiers, economic operators are charged with fees. An e-administrative fee (e-paravolo) is created when the unique identifiers are generated and issued and is due within 30 days of the creation date. An e-mail with the fee details including the amount and payment code is delivered to the e-mail address used for registration. Payment code and amount of the fee are also displayed in the orders list screen of the application.

One can pay the e-administrative fee:

- Using the unique payment code in Greek banks and Post offices
- Via an EU Bank using a SEPA Credit Transfer.

Using any available payment method, the Economic Operator is requested to pay the e-administrative fee within 30 days from the date of generation and delivery of the UIs using the payment code of the fee.

A. Payment in Greek bank or Post-office

Direct payment is supported by the following banks:

Rest of banks as well as post-offices support the payment of the e-administrative fee with a delay in delivering the payment information to the ID Issuer system of 2 working days.
